Life Management Services® works in conjunction with families, the individuals seeking services, trust officers, attorneys and other professionals to meet the current and future needs of an individual with disabilities ensuring maximum independence and appropriate supports.

Life Management Services® can act as an independent case manager, guardian of person and/or estate, trustee, power of attorney, executor and personal budgeting assistant. Other arrangements can be tailored to meet the needs of seniors and persons with special needs.

Life Management Services® works to design services that utilize family and professional resources and other supports to structure a quality life style.



## HOW WE CAN HELP

As guardian, Life Management Services® can help to ensure personal and financial well-being when disability or aging affects an individual's ability to make or communicate decisions. LMS will make substitute decisions on the individual's behalf if necessary while communicating with family, providers, and the individual served.

The Independent Case Manager role, in situations where court appointed guardianship is not necessary, is a critical role that Life Management Services® can play in the life of an individual needing support. This arrangement allows individuals to maintain their independence while remaining linked to care options available to them.

Life Management Services® is also able to serve as trustee for individuals. We are experienced in managing the multiple responsibilities associated with trusts. Working with a financial institution we can ensure money is used to meet the needs of the individual in a cost-effective and responsible manner in accordance with state and federal guidelines. We are also capable of working with established trusts when a trustee may find the social service decisions to be beyond their expertise. We take on the task of guiding the expenditures made so the individual's needs are met within the intentions of the trust.

Concerned about the future care of their relatives, the founders established the agency to ensure there would be guardianship and related services for the person when the family members were no longer able to care for their loved ones.

Merging with the DayOne Network in 2016, DayOne PACT continues to grow beyond guardianship and advocacy services to include community services and early intervention covering the lifespan of an individual with disabilities.

The services DayOne PACT provides have changed, but the one thing that has remained is the agreement or "pact" between the family and the organization.
